Receipt of e-mails will be confirmed; if you don't get a reply to an e-mail, then I did not receive it.

**Armbands:** If you noted on your entry form that you have a permanent or temporary height card, your armband will be available at the check-in table near the jumpers ring, along with course maps for the day. If you did not so note, you will need to come to ask the secretary at the score table for your armbands. If you do not have a height card, your dog will need to be measured by one of the VMOs or judge (we will have one VMO on Friday and two VMOs Saturday and Sunday). If you run and are not measured the AKC will remove any legs you may have earned this weekend.

**Site Rules:** Clean up after your dog, both at the site and at the hotels. Dogs are not permitted off leash outside the building or permitted on any of the outdoor grassy areas except for the marked exercise area. Please use the designated exercise area ONLY. Otherwise this site may not be available to us for future trials. Violators will be excused from the trial without refund.

**Parking:** Park at the northwest end of the sports complex. The main entrance may be used on Friday. Saturday and Sunday **do not use the main entrance, use the northwest entrance** (there will be signs showing where to enter).

**Crating:** Crating areas will be marked. Crate in designated areas only. Please bring a mat or blanket to place under your crate to protect the floor.

**The site will NOT be available for set up Thursday.**

**Food:** The sports complex has a snack bar and outside food is not allowed. Fast food is available nearby.

**Workers:** A worker schedule will be posted on the club website ([wagagility.com](http://wagagility.com)) no later than 7/12. Please check it carefully and contact one of the worker coordinators, Patti Jo Yuswak at [WhtBC10@wi.rr.com](mailto:WhtBC10@wi.rr.com) or Diana Antlitz at [BelgBC@aol.com](mailto:BelgBC@aol.com) by 7/14, if there are any questions or problems or if you will not be able to work as assigned. After 7/14 do not contact Patti Jo or Diana, wait until day of trial and notify the ring captains of any conflicts. Check in with the ring captains (Diane Sanders and Beth Diehl) well ahead of your worker assignment; this will make it easier for us to know of any gaps and fill them in time to keep an efficient trial. Workers will receive lunch, drinks and snacks.

**Refunds:** If you are due a refund, it will be available at the trial at the score table.
